### **Terms of Use for Websites on Brown University Online Platforms**

Please read these Terms of Use (“Terms”) carefully before accessing or participating in in any chatroom, newsgroup, bulletin or message board, mailing list, list serve, forum, website, transaction or other website available at or through [brown.edu](https://www.brown.edu) or other affiliated URL addresses (each such platform is referred to herein as the “Platform”) made available by Brown University or its affiliated entities (collectively, “Brown”).
